FOR RESEARCH APPLICANTS

Sharing access to an application/project

Depending on your role in an application/project the system will give automatic access to view, edit or submit the application/project.

Specific roles are able to share an access. An application/project can be shared with anyone with a REGIS account. This includes people that aren't part of the research team e.g. Sponsors, Coordinators or Collaborators.

Project Registration

Anyone with a REGIS account can create and submit a Project Registration. This person is the Owner of the Project Registration.

Prior to the Project Registration being submitted, the Owner can share access to Project Registration.

Anyone who is given view/edit access at Project Registration will have this across the ethics and site applications.

Ethics Application

The 'Owner' of the ethics application is the person who was indicated as the Coordinating Principal Investigator (CPI) at Project Registration.

The Owner/CPI has responsibility for the management of the study and is the only person who can submit the application. This responsibility cannot be delegated to another role or user.

The person who created Project Registration (if difference to the CPI) is allocated automatic shared - edit access to the ethics application and is also able to share the ethics application with other user.

Anyone who was allocated Shared access at Project Registration will retain this access for ethics.

Share Site Applications

The 'Owner' of the site application is the person who was indicated as the Principal Investigator (PI) at Project Registration.

The **Owner/PI** has the responsibility for the study at the site and is the **only** person who can submit the application. This responsibility cannot be delegated to another role or user.

The person who created Project Registration (if difference to the PI) is allocated automatic shared - edit access to the site application and is also able to share the application with other users.

The CPI is allocated automatic shared - edit access to the site application and is also able to share the application.

Anyone who was allocated shared access at Project Registration will retain this access for the site application.

How to share Project Registration

Sharing at Project Registration can only occur BEFORE Project Registration is submitted. If the Project Registration has been completed (in a status of

Registered) you should follow the steps detailed in *How to Share Ethics/Site Applications*.

Step 1


You can invite people who do not have a REGIS account AND share the Project

Registration with current users by clicking Invite to Register button.

The button appears at:
Part C: Research Site/s
Part D: Coordinating Principal
Investigator

Step 2

The 'Invite user to register or share' wizard will pop up.



Enter the email address of the person who is being shared access.

If the email address is **not recognised** as a registered REGIS account a message will pop up (below) and you will be guided to Invite the user.

Select the level of access you are requesting for the user.

If the email address is recognised as a registered REGIS account a message will pop up and you will be guided to Share.

How to share Ethics/Site Applications

Step 1 Locate your application

When you log in to REGIS, your home page should show your top 5 projects. If you can see the project here, open it by clicking on the project identifier or the title.

If the project is not listed in your top 5 projects, use the top right gold menu bar.



Click the 'Projects' icon to take you to Project View.

A list of projects will appear in a table. Click on the title or identifier to be taken to the Project Details home page.

The project title will appear at the top of the screen and you will see the ethics and governance applications associated with it.

Enter the email address of the person who is being shared access.

Manage/Edit Shared Access

Who can manage/edit shared access?

Project Registration: Only the Owner.

Ethics: The Owner (CPI) of the ethics application and the Owner of the project registration.

Site: The Owner (PI) of the site application, the Owner (CPI) of the Ethics application and the Owner of the Project Registration.

How to manage/edit shared access



This icon will appear next to each application/project that has been shared.

To change (remove/increase) shared access.

Step 1

Select the 'Options' icon to the left of the Ethics/Site Application.

The 'Manage Access' wizard will pop up.



The list of users currently assigned to the application are listed.



Select the drop down list to increase or decrease the access of those listed.



Delete access by selecting this icon.



Resend an invitation to register by selecting this icon.

Save any changes.




Select cancel to close.
