Upcoming Education Sessions

Researcher/Coordinator Education

Upcoming Releases

Reminder that on the <u>3rd March the milestone reminders will be switched on</u>. If you have overdue milestones in the system due to external processing researchers will received reminder emails. Helpdesk has been advised that if they receive calls from researchers who are receiving emails to redirect them to the Research Office to action. Receiving reminders is not a bug or system issue and needs to be addressed by the Research Office.

Please make sure data has been corrected before 3rd March.

Details on how to identify overdue milestones and how to address/correct are in the 9 February email.

Progress Report form

An issue has been identified with the progress report output document not showing all NSW site in the site section. An updated version of the form will be released on the morning of Wednesday 24th. There are no changes to the form that the researchers complete in REGIS. The chance only relates to the information that was previously missing or not showing on the output document that the Research Office review will now appear. Ethics Approval Emails

We have received feedback that the initial approved HREC documents are not consistently being shared with RGO's. This functionality has been available in REGIS for over 24months. It is **CRITICAL** that the Ethics Office follow the steps for approving in the system to allow the RGOs access to the approved documents and Researchers are not asked to upload the documents again. Also, researchers really dislike being asked to reupload documents that are already in the system.

How do I approve an Ethics application in REGIS to share documents with RGO's and external portal?

There are 2 QRG's that describe how to approve an application available:

- Processing Approvals & Authorisations Not associated with Meetings (Initial Application)
- Managing HREC Meetings and Decisions

Approving applications is stepped through in Day 3 of REGIS training, if you need/would like a refresher, please contact Corinne via email EHNSW-Regis@health.nsw.gov.au about attending the next Day 3.

Bulk sending of emails

Site Close Out

Currently REGIS does not have a defined/automated pathway for site close out. This will be addressed in the next round of major enhancements later this year. This is the recommended manual pathway.

Step 1. Researcher submits notification of site close out to RGO, via email, external to REGIS.

Step 2. RGO notes site close out, via email, external to REGIS.


The researcher will still need to submit HREC noted annual/final reports to the RGO.

- If Ethics is in REGIS this will flow automatically on noting of the NSW progress report.
- If Ethics is outside of REGIS a site final report milestone should be manually created for the researcher to allow them to submit. See qrg page 2 for manually creating milestone

Step 3. Upload site close out and RGO notification to Related Documents with document type "milestone report". You can upload an email file, a .zip or multiple documents.

When adding the documents the title will default to the file name, you can change this to a title of your office's choice. Change the document type by clicking on the bottom field and typing "milestone" this will reduce the document type options. Then Click Save.

Step 4. Manually change the status of the STE Project to Completed.

Completed: When the last participant has met the last study analysis endpoint. When reached at a single site study, this is likely the time point when data analysis can begin. When reached at the last site in a multi-site study, this is likely the time point when data analysis can begin. Participants may still be undergoing follow-up visits

Interpretation: Health Care Interpreters PD 2017 044

OHMR has received a query on the use of translated Participant Information and Consent Forms (PISCFs) for non-English speaking participants.

Apparently, one or more commercial sponsors are reluctant to allow non-English speaking participants to be recruited onto their sponsored trials in one NSW Health site, as the sponsor SOPs require a PISCF to be translated into the language of the potential participant, and so are in seeming conflict with NSW Health policy (PD2017_044). While no specific reference has been given, we suspect they are referring to a paragraph on p21:

Non-English consent forms are not used by NSW Health due to a number of risks, including problems with the consistency of content and compatibility with medical record systems.

OHMR has sought advice from the Community Care and Populations Unit of Health and Social Policy Branch (the policy owner). The advice is that:

- Interpreter Policy Directive [PD2017_044] does not exclude the use of translated participant information sheets and consent forms in clinical trials conducted in NSW public health organisations.
- The reference to non-English consent forms is specific to surgical/medical procedures and does not extend to participant information sheets and consent forms for clinical trials.

If Research Offices, or their clinical trial unit partners, receive similar claims from sponsors, reference may be made to this official advice from NSW Health

RESEARCH GEMS (South Australia's new system)

South Australia released its new online application management system at the end of last year. They have joined NSW with an Omni product they have call it <u>RESEARCH GEMS</u>. REGIS and GEMS are <u>VERY</u> similar and

RGO's may start to see forms that look like NSW forms coming from SA. For now SA Ethics needs to be treated like any other outside of REGIS Ethics.

Currently REGIS and GEMS do not talk to each other, this is an issue that OHMR raised with SA (and the Vendor) mid last year as a critical issue. There is a project to have the two systems speak to each other but there is no timeline for implementation, we will keep you posted.
