The annual HREC Chairs and Executive Officers meeting was held at Clifton's Margaret Street in the City last Friday and by all accounts was a very successful meeting.

There was a very interesting presentations from Rob Loblay, Chairman of the RPAH Ethics Review Committee on Managing and Investigating Serious Breaches and an active session where members were invited to raise issues they were currently experiencing with the opportunity to discuss with their peers.

One of the outcomes of the meeting was that members could see value in the opportunity to meet more often and OHMR will begin investigating options such as quarterly online options.

## Affiliated Health Organiation's (AHO) and REGIS

Audience: Research Office/Researcher

In light of some recent discussions we have included a section on Affiliated Health Organisations (AHO). Some Research Offices will be very familiar with AHO as they have close working relationships, other may not come across them very often.....or so they think.

This item is to help clarify how AHOs should or should not appear in REGIS.

#### What is an AHO?

AHOs are Organisations that have a legal definition under the <u>Health Services Act 1997 - section 13</u> but put simply they are Hospitals (that are non-profit, religious, charitable or other non-government institutions) that are treated as part of the public system.

In the context of Research an AHO can be approved as a NSW Health Site by any Lead HREC.

Currently there are two AHO's that are specifically listed in REGIS;

- St Vincent's Hospital Network (Ethics and Sites)
- Calvary Mater Newcastle (Site only)

Both sites are extremely active in Clinical Trials and Medical Research and have well established Research Office and Governance processes.

 Royal Rehab is in the process of being onboarded to REGIS with a final date in late 2022 to early 2023 to be confirmed.

#### A full list of AHOs is available in Schedule 3 of the Health Services Act 1997

#### How this works in REGIS

During the initial submission of an application in REGIS, St Vincent's Hospital Sites (& HREC) and Calvary Mater can be selected during Project Registration.

Site/STE applications will be created in REGIS.



1 - Entering an AHO, at Project Registration, that is a recognised site in REGIS (St Vinvent's)



2 - Entering an AHO, at Project Registration, that is a recognised site in REGIS (Calvary Mater)

For all other AHOs, they can be listed in the "Other" tab in Project Registration. This will allow the site details to be prefilled into the External Sites menu.



3 - Entering an AHO, at Project Registration, that isn't a recognised site in REGIS

#### Amendment Addition of site

St Vincent's and Calvary can be selected as new sites in the NSW tab, STEs will be created.

All other AHOs to be listed on the Other tab, no STE will be created.

St Vincent's and Calvary will appear on Table 1 or 2.

Any other external (to REGIS) sites will need to be manually entered onto table 3.

#### Research Office Contribution

Supporting our Local Research Community - CCLHD Research Office Hello from CCLHD,

The CCLHD Research Office has been busy throughout this year, ensuring that our local research community are supported through various online and face-to-face education sessions. This is in addition to conducting routine review and authorisation of quality improvement and research applications, including pre-submission meetings for staff intending to submit a site specific application via REGIS. At CCLHD, we provide site governance review and can provide assistance with ethics applications; however we don't have an ethics committee (HREC) on site so direct staff to contact the relevant HREC as required.

A quick snippet of what we have been up to:

**Our Research Office** provides a workshop called "Introduction to REDCap" that takes you through how to use REDCap for data management and surveys. To date, there have been 41 participants in 2022 over 4 sessions.

The CCLHD Research Manager, Dr Katherine Bolton has developed a presentation titled "Requirements for QI and Research Projects at CCLHD" which she is delivering to as many Safety & Quality and/or Research Committees as possible to raise awareness of the ethical considerations and requirements before staff commence any quality improvement or research projects at the District. Since June 2022, the presentation has been conducted five times to different departments within the District, including to Clinical Council, with future bookings in place.

The "Kick Start Your Research Project" workshop was developed to give participants the chance to discuss their research ideas with staff from the Research Office, Library and Nursing & Midwifery representatives with extensive experience in research, to devise a plan for the best way to get your research project started. There have been 2 sessions delivered in 2022 with 5 participants.

CCLHD's newest developed education session is called "How to complete a Research application in REGIS". To date, there has only been two sessions with 4 participants. However there are plans to deliver this session again, with proposed dates for the remainder of the year.

The Research Office is also busy organising the rescheduled **2022 Research & Innovation Symposium** after it was postponed earlier this year due to COVID-19. The Symposium will involve Pre-Symposium workshops (including a biostatistics session and grant development workshop) that will be held on Tuesday 29 & Wednesday 30 November 2022, with the Research & Innovation Symposium to be held on Thursday 1 December 2022. The Symposium will include a plenary session, *"Translating Research into Policy and Practice"*, followed by a Clinical Trials Showcase, as well as CCLHD staff and colleagues presenting their Research and Quality Improvement projects through a variety of 15 minute oral presentations, 5 minute lightning talks and poster displays.
