# CTIQ PICF Template: EOI to Review

### Audience: HREC Members

The InFORMed Project was initiated by CT:IQ in March 2021. This project group has reviewed the template information sheets and consent forms (PICFs) for clinical research currently housed on the NHMRC website and used by many sites. These templates often result in long and complex PICFs, containing information unnecessary for most potential participants to make an informed decision. InFORMed is developing nationally consistent, simplified, and more respectful PICF templates.

A draft template and user guide have been created. Consumer testing has been completed, and the group is now seeking feedback from HRECs to review the current PICF template. # National Clinical Trials Governance Framework: Implementation Begins

### Audience: Research Office/Researchers

From **March 2023**, all heath service organisations conducting clinical trials will need to implement the <u>National Clinical Trials Governance Framework</u> in alignment with assessment to the National Safety and Quality Health Service Standards.

### Accreditation timeframe

To give health service organisations time to implement the Framework, for the first three years, or one accreditation cycle, health services will be assessed against a maturity scale.

Health service organisations will be assessed as either having Established systems, Growing systems, or Initial systems in place to meet the NSQHS Standards for clinical trial service provision.

### Support

To assist implementation, the Commission has developed <u>new resources</u>, including a tool to conduct a self-assessment, manage examples of evidence and report on trial operations.



### Background

The Framework is recognised as a significant reform for the clinical trials sector. It embeds clinical trials into routine health service provision under the NSQHS Standards. Importantly, it will do so in a way that will reduce duplication and increase efficiency, cohesion and productivity across the clinical trials sector.

# Clinical Innovation and Research division within the NSW Ministry of Health

Susan Pearce AM, Secretary of NSW Health, has announced the establishment of a new Clinical Innovation and Research division within the NSW Ministry of Health.

The new division will include the Office for Health and Medical Research and the Agency for Clinical Innovation. The creation of the new division will provide a central point for co-ordination and strategy setting, and drive focus on state-wide research and innovation priorities.

The structure for both the Office for Health and Medical Research and Agency for Clinical Innovation will continue as two separate entities overseen by a Deputy Secretary.

Dr Jean-Frédéric Levesque has been assigned the role of Deputy Secretary for Clinical Innovation and Research, and Chief Executive of the Agency for Clinical Innovation and he will guide the transition of this new division. Dr Antonio Penna's as Executive Director of the Office for Health and Medical Research is unchanged.

Recently, Illawarra Shoalhaven LHD asked the GWHREC to take over the review of ethics applications within their district. As you all, may or may not, know, the current arrangement is for a joint committee with Wollongong University but it was felt that the time has come for a change that will benefit both the LHD and the university. The change has the support of the respective Chief Executives and the ethics committee itself. It will mean quite a few administrative changes e.g. the full committee to only review Greater Than Low Risk applications and an extra sub-committee. The new arrangements are expected to be effective from 1 July 2023.

Due to the geographical spread of its members, the committee meets via Zoom except for one annual face-to-face meeting which this year was at the Western Plains Cultural Centre in Dubbo. This meeting allows us to invite guest speakers and helps fulfill the requirement for ongoing training and education.
