How to Request Head of Department Changes

Audience: Research Office/Researchers

In REGIS, Heads of Departments (HODs) are nominated to review the resource implications on their department for Site applications. The NSW Health REGIS team works with Research Offices to update any changes to ensure the relevant HOD is available for selection.

For Research Offices, a formal change request <u>Template</u> can be emailed to <u>REGIS@health.nsw.gov.au</u>, while referring to the <u>New Head of Department QRG</u>. The NSW Health REGIS team has trained a few select Research Office team members on how to correctly update the HOD themselves, meaning these select users are able to update these change requests for their office. It is important to note that unless you have been formally trained/authorised by the NSW Health REGIS team, you **cannot** make HOD changes for your office.

For Researchers who have identified an incorrect (previous HOD) or cannot see a HOD listed for the department they have selected, you will need to contact the reviewing Research Office so they can complete the HOD change/update request.

Please do not contact the REGIS Technical Helpdesk (F1) for HOD change requests.
