Research Office Contribution



Cancer Institute NSW/PHSREC

The team at the NSW Population & Health Services Research Ethics Committee (PHSREC) is a small Ethics team based at the Cancer Institute NSW (CINSW) & Ministry of Health, specializing in all things data. We review all requests for research and health service management purposes of personal health information from state-wide data collections held by NSW Health.

Researchers come to the PHSREC seeking approval for everything from the data linkage arm of a project that was piloted in an LHD (such as the economic evaluation of a trial) to the set-up of huge data assets linking health, education, community, justice and mortality data from NSW and the rest of Australia. We review around 50-80 new linkages each year. We help researchers understand and articulate what consent practices and variables they need to meet their project aims - and what they may need in the future, in terms of gaining data custodian and ethics approvals. Over the past few years we have broadened our focus in line with the changes in the research landscape & the expectations of research funders – such as ensuring projects include consumer-driven aims and working with institutions liberalising access to data. An example of a recent Program approval is the Enduring Cancer Data Linkage that provides NSW Health data to a network of approved and trusted researchers (CanDLe, https://www.cancer.nsw.gov.au/research-and-data/cancer-data-and-statistics/data-available-on-request/candle-program).

It's been incredibly helpful to reach out to our fellow Research Offices when faced with a "new" situation, and we'd like to send a shout-out to those who have given their time to talk to us – for example, discussing registries & consent with the team at SCHN, consumer membership with SLHD and problem-solving with so many ethics and governance teams.

We therefore have a discussion point for other Research Offices – Do you approve Programs of Work/Umbrella Projects? If so, how do you use REGIS to keep track of approved sub-studies, and the associated sub-study sites & investigators? We look forward to hearing from you – Thanks! Chehani & Patrick
