TGA Consultation

As many of you would know, last year the TGA released a consultation paper seeking comment on a new process for reviewing 'high-risk medical device trials'. They have engaged in consultation with all jurisdictions, including the NSW Early Phase Clinical Trial HRECs.

The outcomes of the TGA's consultation on oversight of medical device clinical trials have been published at <u>Proposed regulatory changes for clinical trials of medical devices - Therapeutic Goods Administration - Citizen Space (tga.gov.au)</u>.

Good Clinical Practice (GCP) Inspection Program Metrics report and Webinars

In 2022, the TGA implemented an ongoing risk-based Good Clinical Practice (GCP) Inspection Program. The findings of the inspection program provide confidence in the quality of Australian clinical trials and their compliance with GCP. The <u>first report of the program</u>, which covers the first six months of the program, has now been published. The report provides insights into inspection findings and compliance expectations.

REGIS: Milestone Reminder Emails - Turned Back On

Audience: Research Office

The milestone reminder emails for Ethics Progress Reports were turned back on, on Wednesday 26th July.

Over the recent months we have been preparing users for this by deploying our recent system updates. These updates have assisted in removing inactive studies and Ethics milestones progress reports that were greater than six months overdue from the system, providing you with a true indication of active and compliant studies.

With the reminder emails being turned back, you can now monitor Ethics studies where progress reports are overdue and/or close to being 'Not Achieved'. You can use the 'Project Milestone' dashboard to monitor and plan how to manage progress reports.

Project Milestone dashboard - Filtering options

- Milestone Type Progress Report
- Milestone Due Date this can be filtered to your preference *i.e. 28 days prior to today will show* you milestones that are overdue and would have had the first overdue reminder email sent
- Milestone Status Pending

You can then export this data (see image for highlighted export icon)or review the data on the screen by filtering the 'DueDate' column, this is done by clicking it to see the most overdue progress reports requiring action.

The frequency of the Ethics progress report reminder emails is as follow; the first email reminder will be sent 28 days from the milestone due date and then every 28 days after that until the milestone reaches 180 days overdue, at this point the system will automatically change the milestone status from 'Pending' to 'Not Achieved'. This is noted in the system generated emails.



With the system better monitoring and updating inactive studies and milestones, research offices can now plan to actively or passively manage overdue milestones.

 Active Management: Use the 'Project Milestone' dashboard to review milestones in the 'Pending' status that are overdue, these are highlighted red. You can then speak with the researcher to advise them that urgent submission of progress report is required, or their study may be Suspended.

 Passive Management: Use the 'Project Milestone' dashboard to review milestones in the 'Pending' status that are close to 180 days overdue and/or milestones in the status of 'Not Achieved'. You can then speak with the researcher advising them that their milestone is close to being 'Not Achieved' and their study is at risk, or will be, Suspended unless the progress report is submitted urgently.

The eHealth REGIS team will be conducting a lunch and learn focussed on the recent system updates and how research offices can best utilise the dashboards available to manage study activity.

Research Office Contribution

ISLHD - Increasing Engagement with Heads of Departments and Clinical Stream Leaders

Over the last 6 months, the ISLHD Research Office has increased its efforts to ensure good engagement with our Heads of Departments (HoDs) and clinical stream leaders. The intention is to support the HoDs understanding of their responsibilities when it comes to research, enhance oversight of the scope and quantity of the research being undertaken within their streams, and also to facilitate timely turn-around for Head of Department approval.

Our 3 main methods for increasing engagement have been:

- 1. Using a template to send HoDs an email when we receive an SSA requiring their support. The email provides a brief overview of the project (listing any staff or resources from their stream) and requests their support via REGIS or return email.
- 2. We have streamlined requests from HoDs to know what research projects are being conducted by generating monthly reports for HoDs to show current authorised projects within their stream.
- 3. Our Research Development staff have been attending clinical stream department meetings to increase awareness of research and research services across the district.
