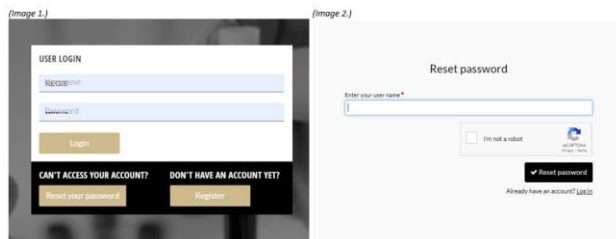

REGIS Product Change: REGIS Account - Identified Inactive Account email

The REGIS product change was completed on Wednesday 22 November 2023, with the main changes occurring to the internal portal used by Research Offices.

One of the changes was the introduction of the REGIS lockout user scheduler email which was created to target inactive user accounts.

How this functionality works: Inactive accounts will be locked after 180 days with two reminder emails being sent at 30 and 150 days. If you receive the reminder email before your account has been locked, simply login and the system will recognise you as an active user. If you are locked out, simply reset your password to access the system.

Due to a technical issue, this reminder email sent earlier than anticipated, on Thursday 23 November 2023. This is no longer an issue and if you have not done so already, we recommend:

- Logging in via the REGIS login pages <https://regis.health.nsw.gov.au/> or <https://regis2.health.nsw.gov.au/> in the first instance **(your username is your email address you registered in REGIS - the email you received was sent to your REGIS username/account)**

- If you are still unable to login then please use the reset your password option <https://regis2.health.nsw.gov.au//Account/ResetPassword>.
