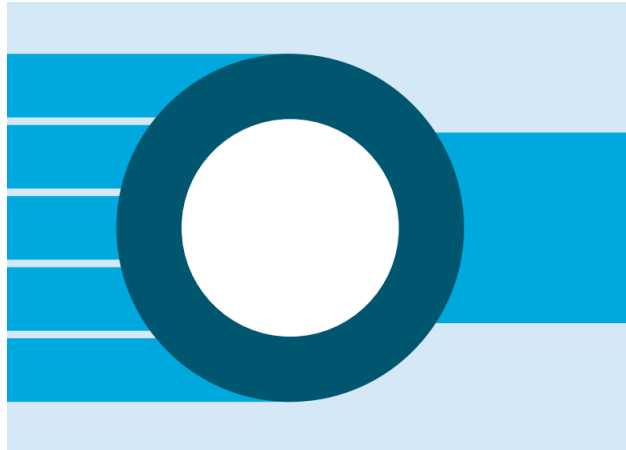

## National One Stop Shop Update

### **Audience:** All

The Commonwealth has released the following to update stakeholders on the next phase to progress the National One Stop Shop

- Minister Butler announced Australian Government funding of \$18.8 million in the 2024-25 Budget to progress the National One Stop Shop.
- Work will now focus on essential technical analysis and testing to de-risk delivery, and work to inform the final business case for government consideration to determine next steps and its preferred approach to implementation.
  - The timeline for delivery of this work is 6-12 months.
  - Funding announced as part of the 2024-25 Budget does not include funding for the build of the ICT platform.



### 1. **Clinical Trial Decision Tree**

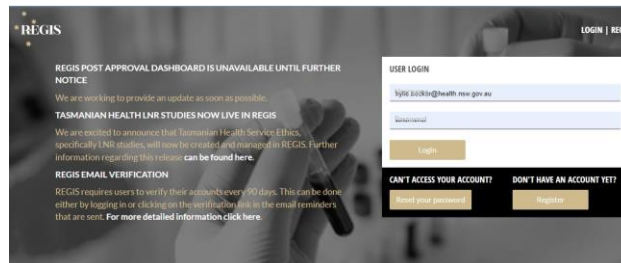
This enhancement will assist Researchers in correctly identifying when the study is a clinical trial according to the WHO and Clinical Trail Governance Framework definition.

This enhancement is a series of questions in the Project Registration, it will also clearly indicate when a study is required to be entered into the NSW Statewide (or SWSLHD) CTMS.

## 2. General HOD upload

This system enhancement will allow Research Offices to update their own Heads of Department by uploading the data directly into REGIS.
