## **REGIS eLearning Module Now Live!**

#### REGIS: The Fundamentals for Researchers & Coordinators


#### Audience: Researchers

The eHealth REGIS team is excited to announce our very first REGIS eLearning module; **REGIS: The Fundamentals for Researchers & Coordinators**, currently available via My Health Learning.

This module has been designed and created by our REGIS Training, Education and Communications SME Corinne McDonough, and looks at the fundamentals of REGIS such as registering your project, creating your ethics and site applications, understanding the external portal and understanding the different user roles and permissions in REGIS.

It has been created to provide researchers and coordinators with a more modern and attractive learning experience and is currently available for NSW Health staff only, but discussions are being held with ACT and TAS Health to share this module with them.

Upon completion, users will have the necessary skills and knowledge to be able to:



- Understand and navigate the different sections of the external portal
- Update your user account and understand what information flows through and to where
- Register your human research project
- Understand what information flows from your project registration to your ethics and/or site applications
- Understand the different user roles and permissions
- Complete an ethics and site application

The module takes approximately 45 minutes to complete, with a certificate issued on successful completion. A second module is currently being created with the focus being on the post-approval activities in REGIS.

OHMR met with the Department of Health and Aged Care on Tuesday 6 August regarding the jurisdiction engagement and the next steps of the National One Stop Shop. Discussions during this meeting were high level with more details expected at an upcoming face to face meeting in early September.

Proposed timeframes for the next phase of NOSS will be tight and we hope that when you have an opportunity to engage, either through responding to surveys, attending webinars or attending workshops you do.

#### **Dates for Information:**

**August:** REGIS user surveys will be widely distributed to seek feedback on from our users their current interactions with the system. Information gathered through these surveys will help us prepare for the early September face to face meeting.

**August:** Each jurisdiction will nominate an SME, Management SME, Technical Contact who will work closely with the Department of Health and Aged Care during the discovery workshops.
