NSW had a site visit with the Alpa Plus team on 1 and 2 October to discuss all things NOSS. It was a great couple of day's and we were excited to have some of our best "on the ground" representatives making sure Alpha Plus were taking their wants and needs into consideration.

### Discovery Workshops Round 1 Complete

The first round of discovery workshops has been completed across the country. Round one was a focus on current state with the Alpha Plus team having the mammoth task of mapping out from first contact by a sponsor of a commercial trial through to study close out with everything in between. We were also

very clear during these workshops with the Alpha Plus team that it's not just clinical trials we are representing, we want NOSS to be a system for all methodologies of human research.

NSW had a range of representation at the discovery workshops including Research Offices, Researchers, CTMS administrators, Technical Advisors and Ministry of Health. We also sought advice of stakeholders through direct communications to supply resources such as current checklists and to provide comment on specific processes, to ensure we were providing the Alpha Plus team with real world experiences.

As the rounds progress we will continue to seek out our subject matter experts.

# World Medical Association Declaration of Helsinki Ethical Principles for Medical Research Involving Human Participants - Updated

#### Audience: Everyone

In October 2024, the World Medical Association updated the Declaration of Helsinki, a key document outlining ethical principles for medical research involving human participants. This revision reflects the growing complexity of medical research, especially in areas like big data, artificial intelligence, and biobanking, which pose new ethical challenges related to consent and data use.

The update also addresses the use of placebos in research, emphasizing stricter guidelines about when it is ethically permissible, especially in vulnerable populations. Additionally, there's a focus on improving protections for participants during pandemics and health emergencies, considering issues like post-trial access to treatments.




A significant structural change involved more clearly distinguishing standards for research combined with medical care and calling for greater transparency in the financial incentives tied to research projects. These revisions were developed through a collaborative process, with input from regional experts and the global research community over the past two years.
