program would be underpinned by a world leading technology solution that consolidates digital access to research services in a centralised, secure and scalable platform.

# REGIS Release: Head of Department Guidance

#### Release 2: 12 February

Audience: Research Office, Researchers, Head of Department

Over the last few months, there have been minor changes and enhancements made to the Head of Department functionality in REGIS. These have been made based on user feedback provided in the 'Use and Barriers of REGIS' survey, circulated in September 2024.

These changes have been aimed at making it easier for Heads of Departments and applicants to navigate the Head of Department support request process in REGIS via streamlined processes, enhancing the user experience, and ensuring clearer communications through a range of improvements.

- ◆ New Head of Department Guidance Webpage A dedicated webpage providing clear and accessible information on Head of Department approvals.
- **Enhanced Video Guidance** Newly created and updated video resources to support users throughout the Head of Department approval process.
- Improved On-Screen Support More guidance for Heads of Departments when reviewing requests for support and applicants when requesting support.

<b>Refined Email Communications</b> – Updates to the Head of Department request for support email to improve readability and legitimacy.
➡ Welcome to REGIS Email – A new onboarding email for Heads of Department to help them get started with their role in REGIS.
Clearer Applicant Guidance in Part C of the SSA Form – Example text and plain English recommendations to help applicants format a quality support request.

### Upcoming Researcher REGIS Training: 4-6 March 2025

**Audience:** Researchers



The eHealth REGIS team offers annual Researcher/Coordinator training as a series of six (6) educational sessions that have been designed to step attendees through submission processes such as submitting the initial project registration through to completing and submitting post approval activities. These sessions provide users with an understanding around how information flows through the system, document management, system notifications and the different types of amendment and safety forms.

Sessions have been designed to allow attendees to attend the whole cycle or standalone sessions specific to their role in REGIS.

Once training has been completed, users will have a better understanding of the submission process, system information flow, when to expect system notifications, user roles and document management!
