National One Stop Shop (NOSS) Information Session Roundup

The National One Stop Shop (NOSS) information session was held on Wednesday 26 February. We know this will be a big project that will continue to evolve, with the aim to ensure a streamlined and equitable approvals platform for health and medical research in Australia and want to keep you up to date with the progress of this project. Below is a roundup of Q&A from the information session:

Broad Access & Inclusion: NOSS will be available for all medical research, promoting equity of access.

Strong Governance & Leadership: Led by the Commonwealth, with all jurisdictions involved in delivery. Governance decisions will follow IGPRG processes, supported by research operations and technical working groups.

Engaging Consumers & Stakeholders: Consumers and carers are involved at all stages with a consultation on HREC accreditation set to open soon.

Regulatory Compliance & Efficiency: NOSS will align with NCTGF requirements, including a low-risk research pathway. Work is currently underway to address approval timeframes to keep Australia competitive.

Secure & Scalable Data Management: The system is designed to securely store large volumes of research data, with a secure environment for data sharing. While the first wave won't house patient-identifiable data, the platform will have the capacity to do so in the future.

System Integration & Interoperability: Integration with CTMS, finance systems, and SDPR is being explored, with API functionality already demonstrated. Further discussions will take place with jurisdictions on complex interactions.

Future Enhancements: Customisable template documents, additional compliance features, and quality measures for NCTGF are all under consideration. The next phase will refine these capabilities to meet user needs.

A number of updates to Project Registration are proposed to better guide the applicant, provide clearer instructions and allow better access to in form guidance. We are seeking your feedback on these proposed changes and how they do or do not address the above issues.

Draft Quality Standards for Human Research Ethics Committees and their Host Institutions - Consultation Survey

Feedback is being sought from different groups of stakeholders to understand how to improve the consistency and efficiency of ethics review processes in Australia.

A set of Quality Standards for HRECs and their Host Institutions (Draft Quality Standards) have been developed, which aim for the highest levels of integrity and ethics/scientific review.

All HRECs in Australia will be eligible to nominate themselves and their host institutions for accreditation to the Quality Standards. Accreditation will reassure the community that the HREC is competent to protect the rights and welfare of research participants, and that the research conducted by the host institution meets ethical standards.

The consultation survey is intended to help understand your views on, and attitudes towards, issues related to ethics review of health and medical research and how it can be improved in the future.

You can <u>complete the consultation survey here</u>, which you can stop the survey at any point, and return to complete it later on. The survey will be open until **Thursday 17th April 2025.**
